UNREPORTED INCOME NOTE: Under USC 26, all income is reportable - even if it isn't taxable. Not reporting income because "no one will know" can result in a ten+ (10) year statute for audit & significant penalties. Accidental mistakes have some penalty risks, but generally there is only a three (3) year audit statute. However, intentionally not reporting income is defined as "Fraud" and the penalty can be as high as 75% of the tax owed plus interest! Don't risk intentionally leaving off income there is "no form" for. These questions assist in identifying reportable income and the associated expenses to lower any tax due and avoid mistakes.
